SWAT Testing Advances

The Smart Water Application Technologies initiative continues to advance the development of water-efficient irrigation technologies through several new testing protocols.



Seven soil moisture sensors have completed phase one SWAT testing. After beta testing of phase two is complete, a draft protocol combining both phases will be released for public comment. Both protocols are administered through the Center for Irrigation Technology at California State University, Fresno.

Rainfall shutoff devices from a number of manufacturers are currently being tested against the SWAT Third Draft Testing Protocol (Oct. 2009) at the University of Florida (Gainesville, Fla.). In anticipation of EPA WaterSense labeling, the testing will determine the accuracy and reliability of the devices under simulated rainfall conditions.

Finally, the first SWAT draft protocol for testing pressure-regulating sprinklers (commonly called pop-up spray heads) is completing its public comment period. Responses from the SWAT Technology Working Group are posted online. Beta testing at North Carolina State University (Raleigh, N.C.) will verify the procedures outlined in the protocol.

Letter From the President



This summer, association volunteers and leaders used your input as the foundation for IA's next three-year evolution. Representatives from the association's committees, certification board, common interest groups and the IA Education Foundation joined the IA Board of Directors in May to create a long-term strategy through 2013.

Approved at the summer board meeting in July, those plans included:

- A revision of the mission statement. IA's mission to promote efficient irrigation now specifies that the organization promotes efficient irrigation technologies, products and services.
- Adding "standards" as a new key initiative, which will focus on establishing efficient irrigation product and practice standards.
- An update of the association's strategic initiatives. Education and certification have been split into separate initiatives to better serve the growing importance of each. Government and public affairs continues to be a key initiative.

These changes will help ensure IA continues shaping the irrigation industry in ways that serve members and ultimately help preserve water for irrigation for future generations.

IA Certification Updates

The Irrigation Association Certification Board has recently made several upgrades to IA's Select Certified program including:

- Simplification of the CEU qualifying activities list, to make submission of continuing education units easier.
- Launch of computer-based testing, to offer more flexible testing options, expedite results reporting, and streamline and secure the testing process.
- Transition to a two-year CEU renewal cycle in 2011, where certified professionals will earn and submit CEUs over a two-year period; renewal fees will still be due annually.
- Implementation of a new cancellation and retake policy; fees for retake exams will be the same as for first-time candidates.
- Launch of the certified agriculture water manager program, debuting at the 2010 Irrigation Show.

Government Affairs Update

A key initiative of the strategic plan, IA's government affairs and public policy activities are a key influence on the irrigation industry for both today's and tomorrow's businesses. In the last few months, the government affairs committee and staff have undertaken several efforts:

- Shaping the *2012 Farm Bill* – IA submitted comments to the U.S. House Agriculture Committee on the current Farm Bill, emphasizing the success and importance of funding the Environmental Quality Incentives Program and the Agricultural Water Enhancement Program. An IA task force focusing on the 2012 Farm Bill was created, and IA staff will continue to introduce positions developed by the task force into the crafting of the 2012 bill.
- Supporting the *Home Star Retrofit Act* – Introduced into Congress in August, this legislation would create consumer rebates for irrigation system retrofits. IA continues to work with allied stakeholders and members of Congress to ensure that water-efficiency incentives are included in the *Home Star Retrofit Act of 2010* and that the services of WaterSense-labeled irrigation professionals are part of a proposed retrofit program.
- Supporting the California water bond – IA recently submitted letters to both California legislators and the steering committee for the Alliance for Clean Water and Jobs in support of the state's *Safe, Clean and Reliable Drinking Water Supply Act of 2010*. IA also supported California's recent postponement to a 2012 ballot in hopes of increasing its chance of success.

Smart Irrigation Month Success



Smart Irrigation Month – the IA-led industry campaign to increase public awareness of the value of water-use efficiency – continues to gain traction. IA Water Conference Report

The second annual IA Water Conference, held July 13-14 in Williamsburg, Va., brought irrigation industry leaders together with academics, government officials, strategists and environmentalists to discuss global water challenges and potential solutions.



Over 90 percent of attendees at the IA Water Conference rated their experience as excellent or good, with 100 percent reporting they engaged in meaningful dialogue.

Event highlights included:

- One-and-a-half days of programming, including tracks for agriculture and turf/landscape issues.
- Keynote address by Colorado Supreme Court Justice Gregory Hobbs on the cultural and historical impact of water on civilization.
- A panel discussion featuring Justice Hobbs and representatives from the Environmental Law Institute, University of Georgia and Dakota Ridge Partners.
- Facilitated audience discussion on the future of water and irrigation.

- In June, the eighth Irrigation Faculty Academy brought 23 irrigation instructors to Riverside, Calif.; they will reach nearly 1,200 students once they return to their classrooms.
- In July, IA's Industry Development Director Brent Mecham attended the American School Counselor Association annual conference, networking with counselors and presenting a seminar about irrigation jobs called "Careers Your Students Need to Know About."
- The student essay and video contest is currently underway; winning students and their faculty advisors will receive all-expense-paid trips to the 2010 Irrigation Show to attend education classes, network with potential employers and learn about the latest technologies and products.
- In October, IAEF representatives will attend the National FFA Convention in Indianapolis to inform students of the numerous careers in irrigation-related fields.
