**Why we need your authorization:** The purpose of this form is to provide authorization required by the Federal Election Campaign Act for the Irrigation Association Political Action Committee to solicit personal contributions from the executive, administrative and professional personnel who are employed by corporations that are members of the Irrigation Association. Corporations may grant prior authorization to only one trade association per calendar year. Permission must be granted by each IA-member company's main contact.

Contributions or gifts to IrrigationPAC are not deductible as charitable contributions for federal income tax purposes. Corporate checks and credit cards are prohibited by federal law. Individuals may contribute up to \$5,000 per year.
